## 1 Summary

In the following we will report on the twelve B centre evaluation round which was carried out Dec 2018 – April 2019 (6 centres). This evaluation round uses the *CLARIN B Centre Checklist*<sup>1</sup> version 6.

For each centre, the assessment committee will recommend if the centre can be granted/re-granted the label as a CLARIN B-Centre, optional give a general comment, and perhaps list remarks or suggestions for improvements.

All centres have the option to clarify the points mentioned below by short statements to the Chair of the CLARIN Assessment Committee and to the chair of the SCCTC in case that the remarks or corresponding evaluation results are not agreed on.

However, reassessment might be needed before the three years has passed if changes in the requirements in the meanwhile are agreed on within the SCCTC.

## 2 General Points

The reviewers in the CAC would like to draw attention to the following general issues.

### *Checks to be ignored when all resources are public available*

The reviewers suggest that SCCTC decides which parts of the checklist that can be ignored if a centre only offers open resources and are planning to keep it that way.

**If centres are only providing public resources and plan to keep it that way, we suggest that they are not obliged to join the SPF and to implement Authentication/Authorisation login.**

### *Test of access from IdPs*

The reviewers cannot always test SP access from both national and non-national IdPs for a centre, but as minimum the test include existence of CLARIN IdP login and the availability of a discovery service for national and non-national IdPs. The assessment committee also wants to thank the AAI taskforce for helping with testing authentication. **However, some centres are not implementing authentication as they only offer publicly available resources.**

### *Automated checks*

Earlier, the SCCTC committee has agreed to aim for more automatic checks of the compliance in the future. CAC has in this round used the metadata curation module<sup>2</sup>. The curation module has been a very useful tool in this round - giving a very useful overview and reporting option for errors. The Centre Registry<sup>3</sup> is still used to give a clear overview of the Service Provider registration with the identity federations.

### *Update of information material about B-centres and checklist needed*

The reviewers see a need for more clear information about the CLARIN concept "B-centre".

### *Quality of metadata*

The reviewers do not make statements about the quality of the metadata or the content of the resources. Only random samples of resources were investigated, and only for the validation of the records, existence of CMDI metadata and PID use.

## 3 Centre Evaluation

### 3.1 LINDAT/CLARIN

It is recommended that LINDAT/CLARIN is prolonged as a CLARIN B centre, when it fulfils the following criteria:

- The CoreTrustSeal is re-granted. Please inform the CLARIN Office when you get the CoreTrustSeal.

Other remarks:

- Some problems were noticed logging in using with two identities sharing the same email address. This might give a problem in some usage scenarios and complicates testing. However, this is beyond the current formal requirements and should be discussed by the CLARIN centre committee and/or assessment committee. It should not influence the certification.

### **3.2 The CLARIN Centre at the University of Copenhagen**

It is recommended that The CLARIN Centre at the University of Copenhagen B is re-granted the label as CLARIN B centre, when it fulfils the following criteria:

- The CoreTrustSeal is granted. Please inform the CLARIN Office when you get the CoreTrustSeal.
- The requirement for a SAML Attribute debug script should be met, which is now disabled for security reasons.

Other remarks:

- Some problems were noticed logging in using with two identities sharing the same email address. This might give a problem in some usage scenarios and complicates testing. However, this is beyond the current formal requirements and should be discussed by the CLARIN centre committee and/or assessment committee. It should not influence the certification.

### **3.3 CEDIFOR - Centre for the Digital Foundation of Research in the Humanities, Social, and Educational Sciences**

It is recommended that CEDIFOR is granted the label as CLARIN B centre, when it fulfils the following criteria:

- The CoreTrustSeal is granted. Please inform the CLARIN Office when you get the CoreTrustSeal.

- The centre arranges a meeting with the national SCCTC member to have a dialogue about fulfilling the criteria mentioned in this section.

Other remarks:

- All resources provided are publicly available. Since the resource centre is only offering resources without access restrictions, the centre is not maintaining a shibboleth endpoint and therefore has no SAML metadata.

### **3.4 DCH - Language Archive Cologne, Data Centre for the Humanities**

It is recommended that DCH – Language Archive Cologne, Data Centre for the Humanities at <https://lac.uni-koeln.de/> is granted the label as CLARIN B centre, when it fulfils the following criterion:

- The CoreTrustSeal is granted. Please inform the CLARIN Office when you get the CoreTrustSeal.

Other remarks:

- There is an issue with the CLARIN IdP implementation that is currently worked on, test will be performed after implementation<sup>4</sup>. Currently, login via SPF can be done via <https://ka3.uni-koeln.de/account/index>.

### 3.5 Eurac Research CLARIN Centre

It is recommended that Eurac Research CLARIN centre repository is granted the label as CLARIN B centre, when it fulfils the following criteria:

- The CoreTrustSeal is granted. Please inform the CLARIN Office when you get the CoreTrustSeal.
- When more than the current four resources are available, to demonstrate that the number of resources grows<sup>5</sup>.

### 3.6 PORTULAN CLARIN Research Infrastructure for the Science and Technology of Language

It is recommended that PORTULAN CLARIN repository is granted the label as CLARIN B centre, when it fulfils the following criteria:

- The CoreTrustSeal is granted. Please inform the CLARIN Office when you get the CoreTrustSeal.
- When ready to remove the “beta”-label from the frontpage of the repository.

Other remarks:

- All resources provided are publicly available. Since the resource centre is only offering resources without access restrictions, the centre is not maintaining a shibboleth endpoint and therefore has no SAML metadata.
