#### 3. Centre assessments

#### Round 19

DVU presents an update on assessment round 19. The report of round 19 was approved by the SCCTC in the previous meeting. DVU has had contact with <u>INT</u>, <u>SAW</u> and <u>ZIM</u> to resolve some last remaining issues. <u>Tübingen</u> has also been contacted, but discussion needs to be finalised.

Two centres have gotten their CTS and have received B-centre status:

- Bayerisches Archiv für Sprachsignale (BAS)
- CLARIN Centre of Latvian language resources and tools

#### Round 20

MW reports that assessment is ongoing and planned to be finalised throughout February.

#### Round 21

DVU gives a short overview of round 21; **deadline:** 21 April 2023.

- The upcoming round will make use of the new CTS specifications and updated B-centre guidelines.
- Both will be published in the upcoming centre news.

## 4. Results of cross-border backup questionnaire and next steps

MM presents the results of the survey. Although only six responses were recorded, there is a clear interest in backing up data:

- ±10TB roughly once a year will be sufficient for most respondents
- In-kind contributions as well as paid storage are an options
- No need for encryption reported
- Generally only little experience with cross-border back-ups across respondents
- CZ and SI already have cross-country back-up agreements → their framework could act as a best practice example for, for example, legal matters (MM to contact them, **AP 17**).

FW highlights the importance of testing back-ups.

## 5. Update on FCS Taskforce meeting 26.1.

MM reports:

- Eric Körner has been onboarded to the taskforce; he works in the context of Text+ (CLARIN-D) as well as for CLARIN ERIC.
- FIN-CLARIN to set up a 2.0 endpoint during February 2023
