1 Summary

In the following the CLARIN Assessment Committee (CAC) will report on the 20th B-centre evaluation round which was carried out between October 2022 and April 2023. This evaluation round uses the *CLARIN B Centre Checklist*¹ version 7.3.1.

For each centre that apply for assessment the assessment committee:

- Recommends if the centre can be granted/re-granted the label as a CLARIN B-centre
- If needed, lists issues that must be improved before granting/re-granting the label
- Gives optional suggestions for improvements (section “Other remarks”)
