Comments on the APs:

- AP 9: Bulgaria now has representative Ivalyo Ivanov joining the SCCTC. DVU explains that Patris van Boxel (Chief Operations Officer, CLARIN ERIC) will be in contact with the countries without CLARIN agreements, which includes Hungary. DVU will also approach Tamás Váradi (NC for Hungary) in Ljubljana.
- AP 10: L-JO reports that SWE-CLARIN cannot offer INCEpTION throughout CLARIN unless there are funds attached.

3. Report on NCF Meeting 17.4.

- MM gives a brief report on the NCF meeting of 17 April in Lisbon, where he presented the status quo with regards to cross-country backups.

- The NCF suggested initiating a task force. Members: Maciej Piasecki and António Branco (NCF), MM and DVU.
 - Suggestion by MM to run a trial back-up with two volunteering centres. Funding and in-kind contribution need to be discussed.
 - MD (Austria) would be interested to pursue this next year, MM (Finland) and L-JO (Sweden) also. FW (South Africa) also interested, but due to technical developments (i.e., automated deployments through Ansible playbooks), this would be only 12 months from now.
 - Further discussions to be had at the <u>Centre Meeting</u>.
